Do you return your town census every year? Are you surprised when you are on the inactive voter list at the polls? The only way that the Board of Registrars can know that you still reside in Westford is by returning your census. The only way to ascertain the current population for grant awards and state funding is through the census. It's that important. The Board of Registrars is responsible for keeping the resident and voter lists up to date and the law obliges them to move non responding voters to the inactive voter list. We want to hear from you! Please return your census form. If you have lost it, please contact the Town Clerk's Office and we will mail you a blank form.

New voters to Westford are reminded that you cannot register to vote on the census form, but we are happy to mail you a registration form or you may download one from www.westfordma.gov. Click on the "How Do I?" button.

DOG LICENSING

All residents are reminded that **the grace period for licensing ends on March 31st** per Town bylaw. That means that a late fee of \$25 will be charged beginning April 1st. The only exceptions are for owners and dogs new to town.

Dog licensing fees for 2015 are as follows:



- **\$15 for spayed/neutered dogs**
- **\$20 for non-altered dogs**
- Residents age 70 and over do not have to pay to license your dog (however, the late fee does apply!)

All dogs ages 6 months and older must receive a rabies vaccination and be licensed per state law. For your convenience, the dog license application form is on the reverse of your census form.

Owners of four or more dogs are required to obtain a "Kennel License" following an inspection by the Animal Control Officer.

CLEAN WATER MATTERS: IT BEGINS WITH YOU

The Town of Westford is launching a "**Stormwater Management Master Plan**" to proactively manage the runoff from rain storms and snow melt (known as "stormwater"). Much of this runoff is carried by drain pipes, which were designed to quickly move the water off the land surface to nearby streams, ponds and wetlands with little or no treatment. On its way over the land, this runoff picks up pollution such as oil, fertilizers, pesticides, salt and pet wastes. This stormwater pollution also gets absorbed into the ground where it travels to the wells that supply our drinking water. **We treasure living, working and playing in the scenic landscape of Westford. Together we can protect the quality of our lakes and ponds and maintain clean drinking water.**

HEALTH DEPARTMENT SHARPS COLLECTION FOR WESTFORD RESIDENTS

In an effort to safely dispose of needles and lancets, the Health Department has a disposal program which offers 2 convenient locations for residents to dispose of sharps. Collection sites are at the Health Department office located on the 2nd floor of Town Hall from 8am-4pm and at the sharps kiosk located in the Police Department entry way, open 24/7. All materials must be delivered in a sharps container, and it is requested that containers are full before dropping them off. This will help minimize costs associated with disposal. No commercial businesses may use this service and it is for Westford residents only.

Please follow these directions to ensure proper disposal of sharps containers:

- No Loose Needles
- All Sharps must be disposed of in a sharps container-if you do not have a personal sharps container, you may use a puncture resistant container such as a one gallon bleach bottle; a one pound sealed and taped coffee can or a 1.5 liter plastic soda bottle
- No glass containers
- No plastic or paper bags
- Do not leave any items outside the kiosk or office

MEDICATION DISPOSAL

This is a great time to clean out those medicine cabinets and get rid of unused, expired drugs or over the counter medications. Empty all pills and medications into Ziploc-type bags. Drop medications in the kiosk at the Police Station Lobby (across from the sharps kiosk), accessible from Town Hall parking lot, 55 Main St. The kiosk is available 24/7. T.R.E.A.D.

(Tax Relief for the Elderly and Disabled) Program

TREAD awards may vary from year to year as funds are dependent upon the generosity of private individuals and businesses. No Town funds from the fiscal budget are used. Voluntary, tax deductible donations by the taxpayers or other individuals are the sole support of this program.

Chapter 60, Section 3D

On May 13, 1997 the Town of Westford voted to accept the provisions of Chapter 60, Section 3D that establishes an elderly and disabled taxation fund. The purpose of this fund is to assist in defraying the real estate taxes of elderly and disabled persons of **low income**. In Westford, the program is administered through the Council on Aging.

Qualification Requirements:

- Must own and occupy the property for which taxes are assessed
- Must be 65+ years old or have a state recognized disability
- Must file completed application disclosing exemptions and household income and expenses for all members age 18+



Every year there is a block for you to indicate whether any household resident served in the military. This year there is a new block for "Surviving Spouse". If you are a widow or widower of an honorable discharged veteran, you may be eligible for many government services as well. Indicating Veteran or Surviving Spouse helps us who deliver services to the residents understand where there may be a need. Checking these blocks is "optional". The Department of Defense nor the Department of Veterans Affairs (the VA) do NOT report to

any local or state agency who the veterans are they are serving. The VA does NOT know you, a Veteran or Surviving Spouse, live in Westford unless you are already receiving services from them today.

Please take a moment to indicate your veterans' status on the form and then give the office a call to find out if there is anything you may be missing from a property tax credit to financial aid. THE J. V. FLETCHER LIBRARY

The Massachusetts Board of Library Commissioners (MBLC) AWARDS the J. V. Fletcher Library a \$50,000 Planning & Design Grant

In 2014 twenty-eight Libraries across the Commonwealth of Massachusetts competed for a state-funded Planning and Design Grant Award. All twenty-eight applications underwent a rigorous, independent grant review process. The applications chosen to receive grant awards were selected based on many factors, including: community need, an understanding of future trends in library services, integration with the library's long-range plan, support from local officials and a plan for community input.

"We are thrilled," notes Library Director Ellen Rainville, "to receive a grant award that allows us to take this step forward in ensuring responsive, state-of-the-art library service for Westford's future. The Feasibility Study that will be conducted with this award will inform and poise the Town of Westford for consideration of the next planning phase – an application under the next projected Massachusetts Public Library Constructions Grand round in 2016 or 2017."

This Feasibility Study will receive support from the Permanent Town Building Committee and will assess the potential for renovation/expansion of the current J. V. Fletcher Library facility on the present Town Common site, as well as site options elsewhere (a grant mandate) for the projected population of 2034. A design of the future Fletcher Library would address the inadequacies identified in the 2013 Library Needs Assessment, plus incorporate new and future trends in service, programs, collections, formats and outreach within the anticipated new space.
